- Income lost as a result of the crime of human trafficking under Government Code sections 13957 and 13957.5;

On January 1, 2020, Assembly Bill 629 went into effect amending Government Code sections 13957(a)(3) and 13957.5(a)(5). These amendments enable victims of human trafficking to receive lost income compensation from California Victim Compensation Board. Specifically, they enable the Victim Compensation Board ("Board") to "authorize compensation equal to loss of income or support that a victim incurs as a direct result of the victim's deprivation of liberty during the crime . . . ." Cal. Gov't Code § 13957(a)(3). They also permit the Board to rely on "evidence other than official employment documentation in considering and approving an application[,] . . . including, but not limited to, a statement under penalty of perjury from the applicant, a human trafficking caseworker . . . , a licensed attorney, or a witness to the circumstances of the crime." Cal. Gov't Code § 13957.5(a)(5)(B). This application is timely because it is being made within X years of the trafficking crime. Cal. Gov't Code § 13953.

As stated in the attached declaration, [Attorney/ Case Worker] has found that [Client Name] has provided a credible statement that s/he is a victim of human trafficking. S/he was trafficked from [date] to [date], and s/he lost income as a direct result of the crime.
